This ad is to serve as legal notice that the Lake-Sumter Metropolitan Planning Organization (MPO) Governing Board will meet virtually on Wednesday, June 24, 2020 at 2 p.m.

The Board will be approving the MPO's Draft FY 2020/21 – 2024/25 Transportation Improvement Program (TIP), the DRAFT 2020 List of Priority Projects, the DRAFT Unified Planning Work Program (UPWP) for fiscal years (FY) 2020/21 and 2021/22, and opening the public review period MPO's Draft Public Involvement Plan (PIP) .

Pursuant to Federal Regulations and Florida Statutes, the TIP identifies a Five Year (FY 2020-21 through FY 2024-25) listing of all transportation projects and programs funded with Federal and State funds, within Lake and Sumter Counties. In addition, local funds (county/city) are also included on selected projects that maybe utilized through various State grant programs. The Final Draft TIP is available for public review and comment on the MPO's website (www.LakeSumterMPO.com) under Public Hearing & Notices, and at the MPO Office in Lady Lake This TIP includes the Federal Transit Administration's (FTA) Program of Projects (POP) for Section 5307 Funding used to provide Fixed Route Transit service for Lake County. The development of the TIP satisfies the federal public participation requirements for the POP.

The Board will be reviewing the MPO's Draft Public Involvement Plan (PIP) and opening a 45-day public review period which will close upon the Adoption Hearing on August 26, 2020. The public is encouraged to participate in the review and adoption of the Public Involvement Plan process. The PIP is a formal guide to how the MPO will involve the public in the transportation planning process and how the MPO will measure the effectiveness of public involvement activities.

The MPO does hereby inform the public that the Unified Planning Work Program (UPWP) for fiscal years (FY) 2020/21 and 2021/22, which contains a description of, and a budget for, the proposed annual planning activities for the MPO staff is available for review and comment. The MPO Board is scheduled to approve the FY 2020/21 – 2021/22 UPWP at their June 24, 2020 meeting. This virtual meeting is scheduled for 2:00 p.m. A public comment period will be held for the UPWP at the meeting, prior to the board taking action on the UPWP.
