### Introduction

The development of the Lake~Sumter Metropolitan Planning Organization's Transportation 2035 plan began early in the process and included a focus on several public involvement activities. A significant effort was made to include all elected officials, agency staff, MPO boards, committees members, civic organizations, regional partners and the citizens of the Lake~Sumter MPO planning area.

The MPO presented the plan at over 120 meetings and events including three public workshops.

#### USING SOCIAL MEDIA TO ENGAGE THE COMMUNITY

The MPO encouraged the use of appropriate Social Media/Web 2.0 (SM/W2.0) technologies to enhance communication, collaboration, and information exchange in support Transportation 2035. These tools are evolving rapidly and are shaping how we work with our, partners, other government agencies, and the public.



For the final phase of TRANSPORTATION 2035, the MPO created a "Facebook Group" as an interactive outreach vehicle for engaging citizens interested in the Plan. The Facebook group page provided a link to the MPO web page, feature project photos and renderings, will help publicize events, and will be a place where citizens can easily participate in the process. The fact that the MPO is as innovative as to employ social media in its planning process will help generate positive coverage for this project. All news

releases and media notices will list the Facebook Page. The public will be invited to post comments on the MPO website via the "Voice your Ideas" section. The results from Facebook will be evaluated before the use of other social media such as Twitter is considered.

#### Response to Public Input

Responses to questions and comments from the public concerning TRANSPORTATION 2035 were made directly to the individual by letter, telephone call or email. Almost all of the public comments concerning TRANSPORTATION 2035 were made during the three workshop series or through the MPO committee proves and were documented on the large format maps used for the workshops and committee meeting. The workshop and committee maps with comments were made available on the Lake~Sumter MPO website after each workshop or committee meeting for further public and agency comment. The only written comments received that were not recorded a map were at the first TRANSPORTATION 2035 workshop from a group of residents of Yalaha concerned about the widening of CR 48 through their community. A copy of the written comments received from this group of residents in included in the appendix of this this document.

#### **Opportunities for Participation**

The MPO took a proactive approach to providing the opportunity for the public to be involved early in the process, and with continuing involvement through all phases of TRANSPORTATION 2035. It was critical to employ effective marketing strategies for the various public involvement activities. The meetings were advertised in MPO newsletter, press releases, web site, radio talk show, public involvement email list, bulletin board postings at government and public places.

Presentations were prepared for each meeting and tailored to meet the needs of those involved. Notifications of all workshops began well in advance of a month ahead of the scheduled date. In additions to legal ads and formal postings announcing the meetings staff also utilized flyers and the website. Speaker cards, comment cards, and sign-in sheets were available at all meetings to record public input and concerns. At the workshops, participants were encouraged to write down their comments and concerns. Speaker comments were also recorded at the workshops, committee meetings and board meetings for the MPO to use in updating TRANSPORTATION 2035. A follow-up



summary of each workshop was prepared and posted to the MPO website.

#### Lake~Sumter MPO Website

The MPO maintained an internet project website providing a forum for the most current information on activities and transportation projects, downloadable plans for each citizen to review interactive maps of transportation projects; links to related sites; and several opportunities to provide commentary to the MPO regarding their plans and programs The website can be accessed at <u>www.LakeSumterMPO.com</u>.

<u>COMMUNITY EVENTS</u> – MPO staff used every opportunity available to speak at community events in Lake County and Sumter County. The Lake County Green Symposium provided the MPO with the chance to moderate a panel of presenters who led the discussion on Green Transportation. Other



unique opportunities included an electric vehicle event hosted by Rube Lab, Lake Vision 2011 and the Lake County Green Fair. Visual displays including story boards were used to present the plan in an easy to understand format. At each event handouts were provided along with comment cards.


#### PUBLIC WORKSHOPS

## COMMUNITY OUTREACH

The Lake~Sumter MPO contacted each of the Chambers of Commerce in Lake County and Sumter County and presented the Transportation 2035 plan. This community outreach began in early 2009 and continued throughout the development of the plan, allowing the MPO to speak at all Chambers and some twice.







#### ETDM PROCESS

The Lake~Sumter MPO provided the public, federal, state, tribal, wildlife, land management and regulatory agencies with reasonable and timely access to technical and policy information relating to the data or content in the development of TRANSPORTATION 2035. Documents were made available for agency and public inspection at the Lake~Sumter MPO Offices, located at 1616 South 14<sup>th</sup> Street, Leesburg, Florida, 34748, during normal business hours, as well as on the Lake~Sumter MPO web site (<u>www.LakeSumterMPO.com</u>), the State's ETDM Public Access website (<u>http://etdmpub.fla-etat.org</u>) and the ETDM Project Diary website (<u>http://cfgis.org/diary/</u>).
