The Purpose of the Executive Committee is to efficiently address matters not feasible to be heard by the full MPO Governing Board. The Executive Committee is also tasked with strategic planning for the MPO, evaluating the MPO Executive Director's performance, and performing other duties as assigned to or requested by the MPO Governing Board. To provide balanced representation on the Executive Committee among counties and municipalities, the MPO Governing Board, at the time of the election of officers, shall attempt to fill, if feasible, officer positions by rotating between municipal and county representatives as officers are advanced, when feasible, to the next level of elected office.

#### B. Executive Director Annual Evaluation:

The Employment Agreement between the MPO and Michael F. Woods requires an annual evaluation to be completed by October of each year. The Employment Agreement's term continues until either party terminates the Agreement. Mr. Woods has been in the MPO Executive Director Position since September 30, 2018. The MPO Attorney's Office has obtained written performance evaluation forms from the Chair and MPO Executive Committee members. Such summaries will be provided to the Executive Director to discuss his evaluation with the MPO Board. MPO Attorney Rachel Bartolowits will lead the discussion of the evaluation and employment agreement with the Executive Committee. The final recommendation will be presented at the December 6, 2023, Governing Board meeting.

A. Recommendation to the Governing Board for approval of the MPO Apportionment Plan. After each decennial census, metropolitan planning organizations (MPOs) must review the composition of their membership and metropolitan planning area (MPA) boundaries and submit an Apportionment Plan that meets the requirements of s.339.175(3), FS, s 339.175(4), FS, and 23 CFR 450.310.

Motion made by Sandy Gamble seconded by Jim Levy - Recommendation to Governing Board to leave voting structure as is and add City Groveland as a voting member due to 2020 Census population data. The City of Groveland is the fifth largest city in Lake County. As per the bylaws the seven largest cities in Lake County are permeate voting members. The City of Minneola joins the seven at-large member rotation. Motion passed 3-0

#### B. Metropolitan Planning Area Boundary (MPA)

The Federal requirements for establishing and adjusting MPA boundaries are in 23 CFR 450.312.

- The MPA boundaries must encompass the existing urban area plus the contiguous area expected to become urban within a 20-year forecast period.
- MPA boundaries must not overlap with each other.
- Where part of an urban area that one MPO serves extends into an adjacent MPA, the MPOs must establish written agreements that clearly identify areas of coordination and the division of transportation planning responsibilities among and between the MPOs.
- MPA boundary maps should be developed at a scale that best meets the needs of the urban area and clearly show the date of the map, scalebar, north arrow, waterways, major routes, transit, intermodal facilities, airports, and names of urban areas.

Motion made by Sandy Gamble seconded by Jim Levy - Recommendation to the Governing Board to keep the MPA as is with the two county boundary serving as the MPA. Motion passed 3-0

C. Approval of Resolution 2023-13 Amending the 2023-24 Unified Planning Work Program (UPWP). This is a non-financial UPWP amendment adding text to Task 4. Michael Woods presented overview of Amendment.

Motion was made by Sandy Gamble to approve Resolution 2023-13 Amending the 2023-24 UPWP, seconded by Jim Ley – motion passed 3-0.
