A. Consider Acceptance of FY 2020/21 Independent Financial Audit and Financial Statement.

MSL, CPA Advisors for Auditing Services, will present the independent audit results performed for the fiscal year from July 1, 2020, through June 30, 2021. The audit is required as a condition of receiving federal funds. After review and approval, the audit documentation will be posted on the MPO website. Joel Knopp, MSL, will present the Independent Audit and Financial Statement.

Motion to accept the FY 2020/21 Independent Audit and Financial Statement.

B. Lake~Sumter MPO Annual Joint Certification with FDOT

Each year, the FDOT District and the Metropolitan Planning Organization (MPO) must jointly certify the metropolitan transportation planning process described in 23 CFR §450.336. The District and the MPO create a joint certification package that includes a summary of noteworthy achievements by the MPO and, if applicable, a list of any recommendations and/or corrective actions. The joint certification begins in January. This allows time to incorporate recommended changes into the Draft Unified Planning Work Program (UPWP). The certification package and statement must be submitted to Central Office, Office of Policy Planning (OPP) no later than June 1.

Motion to approve the Lake~Sumter MPO 2021 Joint Certification Package and authorize the Chair to sign the MPO Joint Certification Statement.

C. Consideration of Approval to Open Public Review Period for the 2045 Long Range Transportation Plan (LRTP) Amendment.

The MPO is required to amend the 2045 LRTP adding \$33,000,000 in American Rescue Plan Act (ARPA) funds for SR 50 from west of CR 757 (Sumter) to CR 33 (Lake). The MPO's Public Participation Plan (PPP) specifies a 21 day public review period. Staff recommends a public review period starting on April 6, 2022, and ending at the next regularly scheduled Board meeting on April 27, 2022.

Motion to Approve the 2045 LRTP Public review period of April 6 through April 27, 2022.

D. Consideration of Approval for MPO Resolution 2022-1

MPO Support for the RAISE Grant Application for the Wekiva Trail project. Lake County, in partnership with the Cities of Tavares and Mt. Dora, is requesting \$25M RAISE funding to complete the approximately \$40M Regional Wekiva Multi-Modal Trail Extension – Segments 1 and 5, the last
