FDOT has requested the following amendments to the approved FY 2020/21-2024/25 Transportation Improvement Program (TIP), adding or amending the following projects:

- FM #439329-3 Lake Sumter Urban Area Funds FY 2020/2021- 2021/2022 UPWP • Lake~Sumter MPO will be adding the remaining PL funds from the closeout of their last UPWP (FY 2019/20) into their Fiscal Year 2021/22 budget. Total \$203,266.
- FM #445297-1 SR 19 From North of Stevens Avenue to CR 452 • Preliminary Engineering funds are programmed in FY 2022, but the project authorization is required before October 1, the new federal year. Total \$4,688,637.
- FM #448899-1 – Lake County BOCC 5310 Capital Assistance Non-Urban This new capital project was awarded to Lake County Public Transportation through the Lake County BOCC to purchase equipment to service the vehicles that are providing transportation to the residents of Lake County. Total \$96,000.
- FM #435471-2 South Sumter Trail SR 471 From SR 50 to CR 478 • Phase C2 (Environmental) funds will allow for the environmental analysis of the trail corridor. C2 funds are programmed in FY 2022, but project authorization is required before October 1. the start of the new federal year. Total \$7,138,417.
- FM #442875-1 SR 44 From East of SR 35/Main Street to Lake County Line ٠ This project aims to resurface SR 44 from east of SR 35 (Main St.) to the Lake County line. Construction funds are programmed in FY 2022, but project authorization is required before October 1, the new federal fiscal year. Total \$17,243,208.
