### B. DRAFT 2022 LIST OF PRIORITY PROJECTS (LOPP)

MPO staff and project consultants will present the DRAFT 2022 LOPP for discussion and comments. FDOT requested major updates to the LOPP format to include projects lists to include:

- TOP 20
- SIS
- Capacity
- TSM&O & Safety
- Complete Streets

- Trails
- Sidewalks & Bike-Ped
- Transit
- Planning/Studies
- Bridges

MPO staff is also considering adding a funded for construction list to aid in making the TOP 20 list more up-to-date. The other big update is integrating the 2021 CMP update data for LOPP projects; this can aid in the prioritization process. After the committee presentations, the DRAFT 2022 LOPP will be posted to the MPO website. FINAL DRAFT 2022 LOPP will be on the June committee and board meeting agendas for review and approval.

### C. DRAFT TRANSPORTATION IMPROVEMENT PROGRAM (TIP)

MPO staff and consultants will present the DRAFT 2023-2027 TIP. MPO consultants developed a new TIP platform with new features to aid in searching and reviewing the funded projects in our planning areas. The new TIP platform includes interactive ArcGIS mapping to help the public review and understand the TIP planning and process. After the committee meetings, the DRAFT 2023-2027 TIP will be posted to the MPO website for public review. FINAL DRAFT TIP will be on the June Committee and Board meeting agendas for approval.
