Interchange Improvements on Turnpike Mainline / SR 91 at US 27 / SR 19 (South) (MP 285) FPID: 452106-1

The project improves the interchange at US 27 / SR 19 (South) by providing additional turn lanes at the ramp terminal intersection. The proposed improvements will provide additional storage lengths, signing and pavement markings, and signalization upgrades.



The table below provides a summary of the projects in FDOT District Five that have funding for Project Development and Environment (PDE – Phase 22), Preliminary Engineering (PE – Phase 32), and/or Right of Way (ROW – Phase 43), but are not currently funded for construction in the Tentative Five-Year Work Program (FY 2026 through FY 2030). The projects listed below are not included in the previous funding tables or map. The Tentative Five-Year Work Program includes funding for phases of the new roadway project (Poinciana Connector, FPID: 446581). The project is part of the Moving Florida Forward initiative which will be delivered by the FDOT Corridor Office. It is subject to a test of economic feasibility, according to Florida Statutes.
