PRESENTATION

A. Florida Department of Transportation and Florida's Turnpike Enterprise Tentative 5-Year Work Programs for FY 2015/16-2019/20

Ms. Vickie Wyche, FDOT District 5 MPO Liaison presented the Tentative 5-Year Work Programs. Discussion.

ACTION ITEMS

A. Recommend Adoption of Public Involvement Plan (PIP)

Mike Woods provided brief explanation of the recommended updates to the PIP and the process for updating the MPO planning documents. He mentioned all of documents are available online but if requested the MPO will provide hard copies. He explained the importance of involving the public in the MPO process. Mr. Woods shared the final action for approval is scheduled for MPO Governing Board meeting in January.

MOTION was made by Susy Gibson to recommend adoption of the Public Involvement Plan Update; seconded by Stephen Stone -- **motion passed 13-0.**

B. 2015 Legislative Positions and Priorities

MOTION was made by Doug Tharp to approve the 2015 Legislative Positions and Priorities; seconded by Steve Printz – **motion passed 13-0.**

C. Election of Vice-Chairman for 2015

Chairman Ferrell explained at the November meeting Jamie Hanja was elected to serve Vice-Chairman; however since that time she pulled her application for reappointment for Lake County.

MOTION was made by Steve Ferrell to appoint Iris Alfonso as Vice-Chairman; seconded by Steve Printz, as there were no further nominations, nominations closed -- **motion passed 13-0**.

DISCUSSION ITEMS

A. <u>List of Priority Projects – Submittal of New Projects</u>

Doug Tharp provided update on the subcommittee meeting held earlier today. He stated the first item discussed was a new website for submittal of projects and shared it will make the implementation easier on staff. He provided a brief explanation of the website and provided information regarding the shorter timeframe and amended schedule. Ms. Richmond said the change in legislative schedule meant for a shorter timeframe for the MPO to adopt the list. She added the web application will be "read only" for the public and shared the information applicants will be able to view.

B. Long Range Transportation Plan

Ms. Richmond shared the LRTP subcommittee met on Jan 9 and provided a summary of the meeting and an overview of the activities completed to date.

C. Upcoming Summits

Mr. Woods stated a summit will be scheduled in March. He discussed the Coast to Coast project and provided a brief update. Mr. Woods explained the importance of regional trails and public transportation.

D. Horizon Award Nominations

Chairman Ferrell provided a brief summary of the history of the Horizon Awards. Mike Woods encouraged committee members to nominate projects by January 16 using the MPO website and added the dinner is scheduled January 28, 2015 at the Clermont City Center.
