  - SR 44 US 441 to Orange Avenue
  - SR 19 Downtown Eustis
  - SR 19 Little Lake Harris Bridge
  - SR 19 Resurfacing (Altoona)

Mr. Fish gave a brief overview of the resolution regarding SR 44. Commissioner Stewart discussed the 4-laning SR 44 versus Round Lake Road. Brief discussion regarding Britt Road realignment/extension.

II. Wekiva Parkway, Wekiva Trail and SR 46 Update

Mr. Fish gave an update on the public hearing. He briefed the committee on the MPO planning process and approved funds. The Lake BCC needs to agree for expressway and location of road and trails. Mr. Fish gave an update on the trail alternatives.

  - SR 44 US 441 to Orange Avenue (Mount Dora to Eustis)
  - Wekiva Parkway (replacing SR 46)
  - US 441 SR 44 to SR 46 (Mount Dora)

  - SR 44 Orange Avenue to CR 46A (Eustis east)
  - SR 19 Downtown Eustis

  - Eudora Road / CR 19A and intersection with CR Old 441
  - Round Lake Road (Mount Dora)
  - CR 437
  - CR 46A

Mr. Fish gave an update on the policy recommendation from the Technical Advisory Committee and discussion ensued regarding concerns of CR 561 through Astatula and also CR 44.

Mr. Fish gave an update on the freight requests and discussed the rail in disrepair from Tavares to Eustis.
