#### A. Bus Shelter Installation and Maintenance Agreement:

The last major update to the TDP was developed in 2008 and the next scheduled major update will be in 2013. *(a draft scope of services for the required minor update will be provided at the meeting for discussion).*

4. Optional Maintenance Requirements: The County retains the option to require the contractor to provide the maintenance function stated in this section based on the pricing values stated by the vendor in the pricing section of this document. If this option is exercised, the contractor shall provide the County a performance schedule for maintaining the shelters. Maintenance of the shelters and amenities shall include but not be limited to repair of the shelter, shelter pad, and amenities; repair, cleaning and replacement of lighting to ensure lighting is in working and compliant condition; and cleaning, as detailed in the following paragraph, of the immediate area of the shelter to keep it safe and functional for all patrons to include full ADA compliance. The contractor will be reimbursed for the cost of any repair caused by circumstances outside of the control of the contractor. The reimbursement shall be based on the repair component costs initially stated by the contractor, and fair value for any additional effort or item.

The contractor shall keep the bus shelters and adjacent areas, including the sidewalks, in a safe condition and free from litter, graffiti, weeds and debris. Graffiti shall be removed within two (2) business days. The contractor shall inspect and maintain each shelter a minimum of once every week as stated herein, or more frequently if needed at high use areas. Maintenance shall include at a minimum: emptying trash receptacles, wiping the bench, sweeping the ground, mowing the grass and cleaning the shelter glass. The contractor shall high-pressure wash each shelter unit and adjacent sidewalk areas at least once every month during the term of the contract.

The contractor shall repair or replace any items due to minor damage or defaced items (including graffiti) on the shelters within two (2) business days after notification by Lake County. Damage which creates or causes a shelter to present a risk of injury to the patrons or public shall be repaired or the item or unit replaced immediately. In the event a shelter is substantially or totally destroyed, the contractor shall remove the shelter within 24 hours and replace such shelter within (30) thirty days of such destruction. Removal costs shall be reimbursed to the vendor at fair market value. Provision and installation of a new shelter shall be based on current contract pricing. The same repair and replacement requirements shall apply to furniture units associated with the shelters. The contractor shall maintain an adequate supply of spare parts to perform the repairs described above.

The contractor will keep current daily and monthly maintenance logs covering both scheduled and on call service of the bus shelters and associated street furniture. The contractor shall provide the County a copy of all logs on a monthly basis.

## It's all about Medicaid next week

Florida Senate leaders next week will release their first detailed proposal for overhauling the Medicaid system, calling for a shift of hundreds of thousands of beneficiaries to managed-care plans.

Senate Health and Human Services Appropriations Chairman Joe Negron, R-Stuart, said this morning he will release a bill next Thursday about how to re-make the \$20 billion program. Designed to cover low-income children, the elderly and disabled, Medicaid has been a lightning rod during budget discussions because of its growth in bad economic times.

Negron said Senate President Mike Haridopolos, R-Merritt Island, has scheduled a special meeting Tuesday on the Senate floor to discuss ideas for changing the system.

Negron said the bill remains a "work in progress."

"We started literally with a blank sheet of paper, and we tried to construct a new Medicaid program that transforms the way we provide care to our fellow citizens," he said.

Meanwhile, aides to Gov. Rick Scott said he will not propose a detailed Medicaid overhaul but will work with the House and Senate to agree on a plan. Like Republican legislative leaders, Scott backs a major shift to managed care to help hold down spiraling costs in the program.

Scott released a budget proposal this week that says the state could save \$1.2 billion during the 2012-13 fiscal year by revamping Medicaid. Such savings would not be possible during the upcoming 2011-12 year because of time it would take to put the mandatory managed-care system in place.

But Negron said he expects to propose a budget during the upcoming legislative session that will cut overall Medicaid spending, at least in part through the program overhaul.

"Our goal is to achieve immediate savings," he said.

Florida is not alone in looking to use managed care to help solve Medicaid budget problems --- other states are considering such moves or have already made them. But many patient advocates and health-provider groups are worried that the overhaul could lead to reduced services for Medicaid beneficiaries.

Two controversial issues during the Medicaid debate will focus on whether a managed-care requirement should apply to people with developmental disabilities such as Down syndrome and to seniors who need long-term care. Jane Johnson, a health-budget aide to Scott, told Negron's committee this morning the governor backs including those groups, though indicated it could take time.

"I think eventually, he would like to see all the Medicaid programs wrapped up in that umbrella," Johnson said.

As Scott and lawmakers get ready to revamp Medicaid, a major unknown is whether the federal government will go along with the state's plans. Federal officials last year declined to grant Florida a straight extension of a five-county Medicaid pilot program that began in 2006, leading to talks that remain ongoing.

That pilot program requires most beneficiaries in Broward, Duval, Nassau, Clay and Baker counties to use HMOs or other types of managed-care plans.

The Senate last year backed expanding the pilot program to 19 additional counties. But senators did not develop a detailed plan to make those changes --- or to go further.

The House, meanwhile, approved a comprehensive bill last year to gradually shift virtually all Medicaid beneficiaries into managed care. House leaders have already said they will use that bill --- which the Senate did not approve --- as a starting point for Medicaid discussions during the upcoming 2011 legislative session.

Exact details of the Senate draft bill remain unknown. But broadly, Negron and Haridopolos have already made clear they will propose a statewide managed-care system.

Legislative leaders also have been looking at the possibility of trying to shield doctors who serve Medicaid patients from costly lawsuits. Negron said such an idea will be included in the Senate bill, though details need to be worked out.

That likely will touch off a controversy, with trial lawyers arguing that lawsuit limits shouldn't be imposed on patients injured by malpractice just become they can't afford private coverage.

# Fla. Senate bill may cut optional Medicaid services, including mental-health care

MIAMI — State Senate leaders may propose cutting dentistry, optometry and mental-health services for Medicaid patients as they try to curb the program's budget, which is expected to top \$21 billion next year.

The emerging Senate bill calls for making cuts in so-called optional services as well as increasing reimbursement rates and limiting legal liabilities for primary care doctors. Although the increased reimbursement rates would cost more, senators want to encourage primary care doctors to continue taking Medicaid patients.

S en. Jo e Neg r on, R-St uart, did not specify an amount, but said the reimbursement rate increase would be more than 2 percent.

The bill will require patients to make an appointment with a primary care physician within 30 days of signing up for Medicaid.

"We're only going to be able to fund essential services," said Negron, who chairs the budget subcommittee that oversees Medicaid. "My goal is that the Medicaid benefit will be comparable to what a citizen in the private sector has, not worse and certainly not better." The Senate will release its proposed Medicaid budget next week, and it comes as federal health officials are trying to guide state lawmakers to save money by limiting certain benefits.

Meanwhile, Gov. Rick Scott this week proposed saving \$1 billion by reducing Medicaid fees paid to hospitals by 5 percent. But Scott has not released additional details for how he would reduce Medicaid spending. The House's proposals are still being drafted.

Florida's Medicaid program for low-income and disabled residents is projected to cost about \$20 billion during the current fiscal year, with the federal government footing more than half the bill. The cost is expected to rise to more than \$21 billion next fiscal year, which starts July 1. The state is also dealing with a \$3.6 billion deficit.

Scott, along with other Republican governors around the country, sent a letter to Health and Human Services Secretary Kathleen Sebelius asking her to tighten the eligibility guidelines so states could cut patients from the Medicaid rolls. Sebelius said she is reviewing the request and instead urged states to find savings by charging higher co-payments for some services, limiting certain benefits and cracking down on fraud and other improper payments.

Federal health officials estimate that roughly 40 percent, or \$100 billion, of all 2008 Medicaid spending nationally was on optional services. They are encouraging states to find savings by limiting optional services that include hospice care, physical therapy and prosthetics.

States have wide discretion in their coverage of optional services. They can eliminate a service or cover it only for targeted groups. Scott said he's reviewing Sebelius' letter, but "doubts that there's a lot of ways that it's going to allow us to make a lot of savings."

Negron also said the Medicaid budget has grown to the "detriment of education," an assertion that has drawn criticism from health advocates.

"If you start cutting these services that are medically necessary, (patients) can't find it anywhere else," said Laura Goodhue, head of the patient advocacy group Florida CHAIN. "That's something you can't get somewhere else — dentures to eat or eyeglasses to see in school. They're trying to make them sound frivolous and like extras but they're not."

Scott and lawmakers also agree on expanding a controversial five-county Medicaid privatization program statewide to save money. Critics say the program saved money because for-profit HMOs delivered fewer services. Patients complain they don't have access to specialists. Several insurance companies dropped out of the program because they couldn't make a profit, leaving patients to find new doctors and navigate the red tape of another plan.

The Senate bill would penalize providers for pulling out of the program by requiring them to post performance bonds. The House bill will also require them to serve in both rural and urban areas to ensure equal access for patients, Republican Rep. Denise Grimsley said.
