- A. <u>Bus Shelter Design</u>: Lake County is using stimulus funds (ARRA) allocated for approximately 20 bus shelters along the fixed route system. The ARRA funds need to be obligated by March 2010; the MPO is coordinating the development of the final design guidelines with the seven municipalities along the fixed route and Lake County.
- B. <u>Bus Shelter Locations</u>: The attached list represents city and county staff recommendations for a first round of as many as 20 bus shelters along the LakeXpress fixed service route. This list of proposed preliminary bus shelter locations was also approved at the Dec. 2 MPO Governing Board meeting.
- C. <u>Mobile Data Terminals:</u> A mobile data terminal (MDT) is a computerized device used in public transit vehicles to communicate with a central dispatch office. Lake County is considering using this new technology to increase efficiency.
