Commissioner Rotella, MPO 2nd Vice-Chairman called the meeting to order at 3:45 p.m. It was noted that the meeting was properly noticed.

I. <u>Status Report on LakeXpress Ridership - David Hope, Lake County</u> David Hope reported the ridership is 14.06% higher than expected. The Leesburg circulator continues to be the highest per ridership.

### II. Status of Vehicle Purchase

**David Hope** shared the BCC approved the request from the LakeXpress Taskforce to purchase new vehicles. They plan to purchase two 30 foot Eldorado EZ Rider II buses with sign boards for the fixed route. The buses are similar to the Bluebird buses they are currently using.

### III. Update on 2020 Transit Development Plan - T.J. Fish, MPO

T.J. Fish reported the TDP will be wrapped up by September with plans to build in connectivity between Lake & Sumter counties included. Discussion ensued reference

# Warketing Partnership Status David Hope reported as of this date there has been one submittal for advertising. Discussion ensued reference advertising countywide and past issues.

VI. Staff Report / Comments

**T.J. Fish** introduced Diane Poitras, D5 liaison. He added David Hope is now employed by the county and the MPO offered to pay  $\frac{1}{2}$  of the position with county for one year. He shared David dedicates his time to the fixed route and will also be working on a portion of the TDP.

**David Hope** shared there will be 300 locations around the county that will eventually have bus signs.

**MPO member and Minneola Mayor David Yeager** suggested the County consider a public/private partnership to fund the bus shelters and benches. Discussion ensued.
