OPENING

TASK FORCE ITEMS

I. Coast to Coast Connector Trail – Status of Segments and Phases

TJ Fish provided an update on the C2C Connector Trail, pointing out segments on the map. Funding opportunities were discussed. Mike Woods commented on the 1941 aerial that was put on the screen. Discussion.

II. Bike/Ped Initiatives: (1) Bike-Walk Central Florida (2) Bicycle-Friendly Community Commissioner Parks shared Amanda Day provided a presentation at the Lake County BCC and focused on *Best Foot Forward* and pedestrian crossing and safety with ideas on what can be done. Bike Walk Central Florida will be on the BCC agenda more frequently. The Lakeshore project was discussed as well as a mobile app that allows you to track your location and routing. It was suggested at some point the traffic on the Southlake trail should be addressed.

III. Complete Streets Initiative

Staff provided an update on the Complete Streets Initiative. Commissioner Sullivan commented on the progress of the Leesburg Complete Streets project and working with FDOT. Discussion regarding Complete Streets training for cities.

IV. Transit: (1) LakeXpress Route 50 (2) LYNX Link 55

Tomika Monterville provided an update via teleconference and discussed the latest route changes. The first round of bus stop pads and shelters are currently being installed. Mike Woods commented on the RouteShout app and how it will help riders know the timing of their bus.
