I. Status of State Road Projects and Funding

T.J. Fish gave a brief update of SR 50 at Plaza Collina; and the SR 50/US 27 intersection being the #1 priority of the MPO.

II. Minneola PD&E Studies and Project Progress Report

Eminent domain is a major concern of Commissioner Renick, and the need to make sure all public is aware of the meeting is of the utmost importance. Further discussion regarding Lake County's process; and the difference between the study and design phases.

III. Status of \$3 Million FDOT Grant for Hartwood-Marsh Road

Mr. Fish gave a brief update and stated that we do not want to be in the situation of losing the grant money. Impact Fee revenues are not coming in for Lake County, and the match is in jeopardy.

IV. LYNX Express Route and Transit Development Plan for South Lake

Mr. Fish explained the new route proposed in North Lake County that will connect with LYNX in Zellwood. Brief discussion regarding a Park and Ride in the Groveland/Mascotte area that would
