

- 1. **SR 500 (US 441) from Lake Ella Road to Avenida Central** Reconstruction project to 6-lane US 441 from Lake Ella Road to Avenida Central (FM 238395-5). Right-of-Way funded estimate \$22.3 million. Construction funded FY 2019 estimate \$33 million. Perkins Street to SR 44 (FM238394-3) Right-of-Way Acquisition estimate \$25 million.
- 2. SR 500 (US 441) from SR 44 to S. of SR 46 A PD&E FY 2013/14 environmental study into possible widening along 1.6 miles. Design FY 2014/15 and Right-of-Way FY 2019/20. (FM 429356-1)
- 3. **SR 25 (US 27) from N. of Boggy Marsh Rd., to N. of Lake Louisa Rd.** Six-laning 6.5 miles from Boggy Marsh Road to Lake Louisa Road (FM No. 238422-1). Design has been completed and right of way acquired. Construction funded FY 2016.
- 4. **SR 44 (CR 44B) from SR 500 (US 441) to SR 44** Design for four-laning the two miles from US 441 to SR 44 is in progress (FM No. 409870-1). Right of way FY 2014/15. Construction not yet funded.
- 5. **SR 46 from SR 500 (US 441) to Seminole Co. Line** An environmental study is being conducted by the Central Florida Expressway Authority along the 16.5 miles from US 441 to Orange Blvd. in Seminole County (FM No. 238275-1) in conjunction with their study of the Wekiva Parkway.
- 6. **SR 19 from CR 48 to CR 561** An environmental study (PD&E) into possible widening along the 4.7 miles from CR 48 to CR 561 is planned for FY 2011/12 (FM No. 238319-1). Design estimate \$2.9 million in FY 2014/15.
- 7. **Rolling Acres Road Vista San Polo to Griffin Rd./Villages Elementary Sidewalk** \$830,000 in grants to the City of Lady Lake through FY 2012/13 is to pay for design and construction of a sidewalk (FM 427855-1). LAP with Town of Lady Lake.

## SUMTER COUNTY CONSTRUCTION IN PROGRESS

#### 242626-2-52-01: I-75 Improvements from North of Hernando County Line to South of CR 470.

Widen I-75 from four (4) lanes to six (6) lanes, complete interchange construct at State Road 48 (Exit 314) new ramps at the CR 476B/CR 673 (Exit 309 Interchange) Intelligent Transportation Systems (ITS) improvements. Drainage, guardrail, signing and pavement markings, signalization, milling and resurfacing, and miscellaneous structures.

Estimated completion date: Winter 2016 – 27% complete – Project cost: \$76.9 million

#### **RESOLUTION 2015 –**

A RESOLUTION OF THE LAKE~SUMTER METROPOLITAN PLANNING ORGANIZATION (MPO), AMENDING THE FY 2014/15-2018/19 TRANSPORTATION IMPROVEMENT PROGRAM AND AUTHORIZING THE SUBMITTAL OF THE AMENDED FY 2014/15-2018/19 TRANSPORTATION IMPROVEMENT PROGRAM TO THE APPROPRIATE AGENCIES.

WHEREAS, the Lake~Sumter Metropolitan Planning Organization (MPO) is the duly designated and constituted body responsible for carrying out the urban transportation planning and programming process for the Lake-Sumter Planning Area; and

**WHEREAS,** Florida Statutes 339.175, 23 U.S.C. 134, and Title 49 U.S.C. require that the MPO, as a condition to receiving federal capital or operating assistance, has a continuing, cooperative, and comprehensive transportation planning process that results in plans and programs consistent with the approved comprehensive plans of the units of local government within the MPO's jurisdiction, and with state and local planned growth and economic development patterns; and

**WHEREAS,** 23 C.F.R 450.324 provides that the Lake~Sumter MPO shall develop a Transportation Improvement Program (TIP) for the metropolitan planning area, and 23 C.F.R. 450.326 allows an MPO to revise the TIP at any time under procedures agreed to by the cooperating parties and consistent with 23 C.F.R. 450.326; and

**WHEREAS**, the FY 2014/15 - 2018/19 TIP was adopted by the MPO on June 25, 2014, based on programmed projects in the Florida Department of Transportation (FDOT) Five Year Work Program; and

**WHEREAS,** the FY 2014/15 – 2018/19 TIP was amended by the MPO on September 24, 2014, in order to achieve consistency and to address roll-forward funds and adjustments to the FDOT Work Program, and to add, as an Appendix, Lake County's FY 2014/15-2018/19 Transportation Construction Program and Sumter County's FY 2014/15-2018/18 Capital Improvement Plan; and

**WHEREAS,** the FY 2014/15 – 2018/19 TIP was amended by the MPO on October 22, 2014, in order to program funds towards the SR 44 Bridge crossing over the St. John's River and the South Lake Trail, Phase 4; and

**WHEREAS**, the FY 2014/15 – 2018/19 TIP was amended by the MPO on March 11, 2015, in order to program funds for the SR 19 Project Development and Environment Study, for the US 27 sixlane construction project, lighting and construction at intersection of CR 455 and CR 561 and capital funds for fixed route transit within Lake County; and

WHEREAS, the FY 2014/15 – 2018/19 TIP was amended by the MPO on April 22, 2015, in order to program funds for rail safety projects at County Drive and at Lake Dora Circle, for signing and pavement markings on SR 19, for construction of paved shoulders on CR 475 in Sumter County, for construction of paved shoulders on CR 470 from CR 439 to SR 44 in Sumter County, and for construction of paved shoulders on CR 575 from north of CR 476 to south of CR 624 in Sumter County; and

- **WHEREAS,** the Lake~Sumter Metropolitan Planning Organization (MPO) has been designated by the Governor of the State of Florida as the body responsible for the urban transportation planning process for the Lake-Sumter Urban Area; and
- **WHEREAS,** Title 23 CFR Section 450.308(c) and Florida Statute 339.175(9) require each Metropolitan Planning Organization to annually submit a Unified Planning Work Program (UPWP); and
- **WHEREAS,** a Unified Planning Work Program is defined as a statement of work identifying the planning priorities and activities to be carried out within a metropolitan planning area during the program years and the UPWP includes a planning budget; and
- **WHEREAS,** the Lake~Sumter MPO adopted its FY 2014/15 through FY 2015/16 UPWP on April 23, 2014, for the period July 1, 2014, through June 30, 2016; and
- **WHEREAS,** the Lake~Sumter MPO amended its FY 2014/15 through FY 2015/16 UPWP on June 25, 2014, by updating budget tables to reflect actual Planning Grant allocations and additional funding for planning assistance; and
- **WHEREAS,** the Lake~Sumter MPO amended its FY 2014/15 through FY 2015/16 UPWP on August 27, 2014, by making minor changes to the text of the adopted UPWP per agency review by the Florida Department of Transportation and the Federal Highway Administration; and
- **WHEREAS,** the Lake~Sumter MPO amended its FY 2014/15 through FY 2015/16 UPWP on October 22, 2014, by adding \$125,000 of State Funds, Category D, for FY 2014/15 for assistance in developing the 2040 Long Range Transportation Plan; and
- **WHEREAS,** the Lake~Sumter MPO amended its FY 2014/15 through FY 2015/16 UPWP on April 22, 2015, to add \$10,000 of State Funds, Category D, in FY 2014/15 to assist the MPO's two-county traffic counts program data collection effort and to add \$50,000 of State Funds, Category D, in FY 2014/15 for a feasibility study to determine the viability of a traffic calming project on SR 44 (Dixie Ave) from 12th Street to US 441 (North Boulevard); and
- **WHEREAS**, the FY 2014/15 through FY 2015/16 UPWP requires amendment to update agency grant amounts for FY 2015/16; and
- **WHEREAS,** the amended UPWP financial tables, Table III and Table IV, for FY 2015/16 require amendment to reflect a Federal Highway Administration planning grant amount of \$531,543, to reflect a Federal Transit Administration grant and FDOT matching funds totaling \$120,184 and a local soft match of \$13,354, and to reflect Florida Commission for the Transportation Disadvantaged grants totaling \$46,249.

#### **RESOLUTION 2015 –**

RESOLUTION OF THE LAKE~SUMTER METROPOLITAN PLANNING ORGANIZATION ADOPTING THE ANNUAL LIST OF PRIORITY PROJECTS FOR FY 2020/21 THROUGH FY 2034/35 AND AUTHORIZING TRANSMITTAL OF THE NEW FUNDING PRIORITIES TO THE FLORIDA DEPARTMENT OF TRANSPORTATION.

**WHEREAS,** the Lake~Sumter Metropolitan Planning Organization (MPO) is the duly designated and constituted body responsible for carrying out the urban transportation planning and programming process for Lake~Sumter Planning Area; and

**WHEREAS,** Florida Statutes 339.175; 23 U.S.C. 134; and 49 U.S.C. 5303 require that the urbanized area, as a condition for the receipt of federal capital or operating assistance, has a continuing, cooperative, and comprehensive transportation planning process that results in plans and programs consistent with the comprehensively planned development of the urbanized area; and

**WHEREAS,** Florida Statutes 339.175(8)(a) requires that the MPO is responsible for developing, annually, a list of project priorities ranking the transportation needs of the MPO area; and

**WHEREAS,** the prevailing principles that must be considered by the MPO when developing the List of Priority Projects are preserving the existing transportation infrastructure, enhancing Florida's economic competitiveness, and improving travel choices to ensure mobility; and

WHEREAS, the List of Priority Projects must be based upon project selection criteria that considers, in part, the MPO long range transportation plan; the Florida Department of Transportation (FDOT) Strategic Intermodal System Plan; criteria consistent with projects eligible to receive funding from the Transportation Regional Incentive Program outlined in Florida Statutes 339.2819(4); the results of the transportation management systems; and the MPO public involvement plan; and

**WHEREAS**, the List of Priority Projects must be used by the FDOT in developing the district work program and must be used by the MPO in developing its transportation improvement program; and

WHEREAS, the FDOT has established a deadline of July 1, 2015, for the submittal of new project priorities, pursuant to Florida Statutes 339.175(8)(b), for funding in state FYs 2020/21 through FY 2034/35, with said priorities serving as a basis upon which FDOT District 5 makes funding decisions relative to the FDOT five-year Work Program; and

WHEREAS, the Lake~Sumter MPO, serving the role of prioritizing all federal-aid roadways including certain county roadways, also has prioritized county transportation projects in order to address regional county transportation needs within the MPO Area.

#### **NOW, THEREFORE, BE IT RESOLVED** by the Lake~Sumter MPO:

- 1. The FY 2020/21 FY 2034/35 List of Priority Projects was developed with consideration given to preserving the existing transportation infrastructure, enhancing Florida's economic competitiveness, and improving travel choices to ensure mobility; and
- 2. The FY 2020/21 FY 2034/35 List of Priority Projects is consistent with the MPO's adopted long range transportation plan, *TRANSPORTATION 2035*, which was adopted December 8, 2010; and
- 3. The FY 2020/21 FY 2034/35 List of Priority Projects is consistent with the FDOT Strategic Intermodal System Plan; and
- 4. The FY 2020/21 FY 2034/35 List of Priority Projects was developed in consideration of criteria consistent with projects eligible to receive funding from the Transportation Regional Incentive Program outlined in Florida Statutes 339.2819(4);
- 5. The FY 2020/21 FY 2034/35 List of Priority Projects was developed in consideration of the results of the transportation management systems;
- 6. The FY 2020/21 FY 2034/35 List of Priority Projects was developed using the procedures of the MPO public involvement plan; and
- The FY 2020/21 FY 2034/35 List of Priority Projects is hereby endorsed and adopted;
   and
- 8. The Chairman of the MPO is hereby authorized and directed to submit the list of priority projects to the Florida Department of Transportation and to the chairman of both the Lake County and the Sumter County Board of County Commissioners.
