A RESOLUTION OF THE LAKE~SUMTER METROPOLITAN PLANNING ORGANIZATION (MPO). AMENDING THE FY 2015/16-2019/20 TRANSPORTATION IMPROVEMENT PROGRAM AND AUTHORIZING THE **SUBMITTAL OF** THE AMENDED FY 2015/16-2019/20 TRANSPORTATION IMPROVEMENT PROGRAM TO THE APPROPRIATE AGENCIES.

WHEREAS, the Lake~Sumter Metropolitan Planning Organization (MPO) is the duly designated and constituted body responsible for carrying out the urban transportation planning and programming process for the Lake-Sumter Planning Area; and

WHEREAS, Florida Statutes 339.175, 23 U.S.C. 134, and Title 49 U.S.C. require that the MPO, as a condition to receiving federal capital or operating assistance, has a continuing, cooperative, and comprehensive transportation planning process that results in plans and programs consistent with the approved comprehensive plans of the units of local government within the MPO's jurisdiction, and with state and local planned growth and economic development patterns; and

WHEREAS, 23 C.F.R 450.324 provides that the Lake~Sumter MPO shall develop a Transportation Improvement Program (TIP) for the metropolitan planning area, and 23 C.F.R. 450.326 allows an MPO to revise the TIP at any time under procedures agreed to by the cooperating parties and consistent with 23 C.F.R. 450.326; and

WHEREAS, the FY 2015/16 - 2019/20 TIP was adopted by the MPO on June 10, 2015 based on programmed projects in the Florida Department of Transportation (FDOT) Five Year Work Program; and

WHEREAS, in order to achieve consistency and address roll-forward funds from the previous fiscal year and adjustments to the FDOT Work Program, the FDOT has requested in a letter dated July 31, 2015, that the MPO amend the FY 2015/16 – 2019/20 TIP to address necessary revisions and additions as listed in Exhibit "A" and Exhibit "B"; and

WHEREAS, on August 4, 2015, the Lake County Board of County Commissioners adopted the FY 2015/16-2018/20 Transportation Construction Program as a five-year strategic planning document of programmed transportation projects and phases; the new program is effective October 1, 2015; and

WHEREAS, on September 22, 2015, the Sumter County Board of County Commissioners adopted the FY 2015/16-2019/20 Capital Improvement Plan as a five-year strategic planning document of programmed capital projects, including transportation projects and phases; the new program is effective October 1, 2015; and

WHEREAS, the Federal Highway Administration reviewed the new TIP and provided a letter of comments that require two textual amendments to further elaborate on the MPO's public involvement process in developing and amending the TIP and on the regionally-significant projects included in the new TIP.

- 3. The FY 2015/16-2019/20 TIP is hereby amended to address comments from the Federal Highway Administration by amending text in the Purpose section of the TIP introduction as follows:

PURPOSE

The purpose of the Transportation Improvement Program (TIP) is to provide a staged, multi-year, intermodal program of transportation projects, consistent with the Transportation 2035, Lake~Sumter MPO 2035 Long Range Transportation plan (LRTP). The TIP is required of all metropolitan areas, under Section 134 of Title 23, United States Code (USC), as amended by the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) of 2005. The TIP includes improvement projects for the highway, transit, bicycle/pedestrian and rail systems.

The Lake~Sumter MPO TIP contains all transportation projects within the Lake County and Sumter County metropolitan areas designated for funding from Title 23 and Title 49 funding sources and all regionally significant transportation projects requiring federal

action, regardless of funding source. Projects of regional-significance in this iteration of the TIP include segments of the Wekiva Parkway in eastern Lake County including improved SR 46/US 441 Interchange, SR 46 improvements, a new SR 429 and a new alignment of CR 46A. The TIP also includes improvements to US 27 in southeastern Lake County, improvements to US 441/27 in Lady Lake, improvements to SR 48 in Bushnell, improvements to I-75 in Sumter County and a new interchange with Florida's Turnpike in Minneola. The TIP includes right-of-way funds for US 441 in Mount Dora and for Citrus Grove Road in Minneola. The TIP also includes design funds for Florida's Turnpike in Lake County.

4. The FY 2015/16-2019/20 TIP is hereby amended to address comments from the Federal Highway Administration by amending text in the Public Involvement section of the TIP introduction as follows:

PUBLIC INVOLVEMENT

Annually, the Lake~Sumter MPO develops its TIP in accordance with all applicable State and Federal laws governing public involvement. This includes 23 CFR 450.316 and 23 CFR 450.324(b). Specific procedures for use of public involvement in the annual development of the TIP have been clearly defined in the MPO's adopted Public Involvement Process (PIP). Prior to adoption of the final TIP, the Lake~Sumter MPO sought public comment on the draft TIP by making the document available on our website (LakeSumterMPO.com). In addition, all Lake~Sumter MPO meetings are held in accordance with Florida's open meetings law (the Sunshine Law), and an opportunity is provided for public comment. The new TIP was presented as a draft document at the April meetings of the Technical Advisory Committee, the Citizen Advisory Committee, the Bicycle & Pedestrian Advisory Committee and the Executive Committee. The draft TIP was on the agenda of the April 22 Lake~Sumter MPO Governing Board meeting. The final TIP document was recommended for approval by all MPO committees in May and was granted final approval by the MPO Governing Board June 10, 2015. Amendments to the TIP document occur throughout the year through a process that follows the MPO's PIP. Amendments are presented to MPO committees for public input and recommendations. After being posted for 21 days, the MPO Governing Board takes action to approve TIP amendments. Public comments received at public meetings are incorporated into the TIP document as applicable and feasible.

- 5. The FY 2015/16-2019/20 TIP is hereby amended to incorporate regionally significant projects from Lake County's FY 2015/16-2019/20 Transportation Construction Program and to add this document as Appendix "A" to the TIP; the county's five-year program is effective October 1, 2015.
- 6. The FY 2015/16-2019/20 TIP is hereby amended to incorporate regionally significant projects from Sumter County's FY 2015/16-2019/20 Capital Improvement Plan and to add this document as Appendix "B" to the TIP; the county's five-year program is effective October 1, 2015.
- 7. The above amendments are effective October 1, 2015.
- 8. The Chairman of the Lake~Sumter MPO is authorized to submit, and hereby submits, the amended FY 2015/16 2019/20 TIP to the:
 - a. Federal Highway Administration (FHWA) through the Florida Department of Transportation (FDOT);
 - b. Federal Transit Administration (FTA) through FDOT;
 - c. Federal Aviation Administration (FAA);

General Comment: Is it possible to add page numbers to the TIP document? The MPO's TIP document is posted online as a PDF document in Adobe Reader, which provides page numbering on the toolbar. The PDF document is 58 pages. The MPO is addressing the software's pagination function to show page numbers on the PDF document. As you know, the TIP is a compilation of various documents combined into a final PDF document. The pagination will be addressed in next revision.

Page 9 of 58: It is recommended that the MPO expand the public involvement section of this document to detail the TIP amendment process. While this information may be provided in the MPO's PPP this information should also be included in the actual TIP document.

Also how does the MPO respond to any comments submitted about the TIP? This discussion of how the public's input will be used should also be added to this section (a simple statement will suffice).

As part of the September amendment that will include a roll-forward of funds from FY 2014/15, the following text will be added to address the comments:

PUBLIC INVOLVEMENT

Annually, the Lake~Sumter MPO develops its TIP in accordance with all applicable State and Federal laws governing public involvement. This includes 23 CFR 450.316 and 23 CFR 450.324(b). Specific procedures for use of public involvement in the annual development of the TIP have been clearly defined in the MPO's adopted *Public Involvement Process (PIP)*. Prior to adoption of the final TIP, the Lake~Sumter MPO sought public comment on the draft TIP by making the document available on our website (LakeSumterMPO.com). In addition, all Lake~Sumter MPO meetings are held in accordance with Florida's open meetings law (the Sunshine Law), and an opportunity is provided for public comment. The new TIP was presented as a draft document at the April meetings of the Technical Advisory Committee, the Citizen Advisory Committee, the

Bicycle & Pedestrian Advisory Committee and the Executive Committee. The draft TIP was on the agenda of the April 22 Lake~Sumter MPO Governing Board meeting. The final TIP document was recommended for approval by all MPO committees in May and was granted final approval by the MPO Governing Board June 10, 2015. Amendments to the TIP document occur throughout the year through a process that follows the MPO's PIP. Amendments are presented to MPO committees for public input and recommendations. After being posted for 21 days, the MPO Governing Board takes action to approve TIP amendments. Public comments received at public meetings are incorporated into the TIP document as applicable and feasible.

Page 9 of 58- States that "The draft TIP was on the agenda of the May 2012 Lake-Sumter MPO Governing Board meeting. I am assuming this is a typo and it should say May 2015 but just wanted to double check.

The date is in error and will be corrected as noted above.

I did not find a discussion about regionally significant projects in the introduction. Does this plan include any regionally significant projects? If yes, it would be helpful to have these projects listed and/or summarized in the introduction of the TIP.

The Purpose section in the introduction is being amended as follows:

PURPOSE

The purpose of the Transportation Improvement Program (TIP) is to provide a staged, multi-year, intermodal program of transportation projects, consistent with the *Transportation 2035*, Lake~Sumter MPO 2035 Long Range Transportation plan (LRTP). The TIP is required of all metropolitan areas, under Section 134 of Title 23, United States Code (USC), as amended by the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) of 2005. The TIP includes improvement projects for the highway, transit, bicycle/pedestrian and rail systems.

The Lake~Sumter MPO TIP contains all transportation projects within the Lake County and Sumter County metropolitan areas designated for funding from Title 23 and Title 49 funding sources and all regionally significant transportation projects requiring federal action, regardless of funding source. Projects of regional-significance in this iteration of the TIP include segments of the Wekiva Parkway in eastern Lake County including improved SR 46/US 441 Interchange, SR 46 improvements, a new SR 429 and a new alignment of CR 46A. The TIP also includes improvements to US 27 in southeastern Lake County, improvements to US 441/27 in Lady Lake, improvements to SR 48 in Bushnell, improvements to I-75 in Sumter County and a new interchange with Florida's Turnpike in Minneola. The TIP includes right-of-way funds for US 441 in Mount Dora and for Citrus Grove Road in Minneola. The TIP also includes design funds for Florida's Turnpike in Lake County.

MPO Response to FHWA TIP Comments Page 3 of 3

Can the MPO please clarify how fiscal constraint is being ensured for this TIP document?

Fiscal constraint is addressed in the Financial Plan section of the introduction. Fiscal constraint of the TIP is directly tied to the cost-feasible 2035 Long Range Transportation Plan. The MPO, with the assistance of the FDOT, monitors allocations of federal and state transportation funding throughout five-year periods. This monitoring is to ensure the MPO is receiving at least the level of funding indicated in the cost-feasible LRTP and fair-share allocations for each county as required under state law.

Were there any major projects from the last TIP that were implemented or delayed since the last TIP?

No projects were delayed or moved to a later fiscal year from the last TIP to the new TIP. A Project Development and Environment Study was completed for SR 19 in Tavares and Howey-in-the-Hills. Right-of-way acquisition was completed for US 441 in Leesburg. Design of Citrus Grove Road in Minneola is underway. Two design/build projects are underway: I-75/Florida's Turnpike Interchange and Florida's Turnpike interchange with North Hancock Road in Minneola.

Does the MPO have a CMP? I did not find any reference to the CMP in this document. Are measures from the CMP reflected in the TIP?

The MPO now has a CMP but did not have one when Transportation 2035 was developed. Although the MPO is not a Transportation Management Area (TMA), the MPO developed the CMP with assistance from the FDOT. Transportation 2035 goals were used to develop the CMP. Now that the MPO is updating the LRTP, the CMP is being used to generate the MPO's goals, objectives, measures and targets for the new plan as well as future updates to the MPOs List of Priority Projects. Informally (meaning without actually referencing the CMP) the TIP and LOPP both adhere to CMP developed for the MPO.

I did a spot check of project 4313521-238275-3. In the TIP this project is described as SR 46 From East of Vista View Lane to East of Round Lake Road. In the MPO's LRTP I found a project described as SR 46 Segment 3A from East of Pond Road to East of Round Lake Road. Is this the same project? If yes please work to ensure that there is consistency between how the projects are described between planning documents. I know some time the more common name is used which is fine but we do want to make sure that the detail of the project is consistent.

Yes, the SR 46 Project (FM#2382753) is the same project on both documents. The MPO is correcting details to reflect consistency between both documents.



STATEWIDE TRANSPORTATION FUNDING

1. Support Allocation of a Portion of Funds Generated through Amendment 1 to Recreational Trails and Maintenance

The Development of the Coast to Coast Connector and the Heart of Florida Loop and other trails of statewide significance will provide an international attraction for ecotourism. Currently, the maintenance of these facilities falls primarily to local governments. Dedicating a portion of the funds generated from Amendment 1 to trail development and maintenance will allow local governments and agencies to expand and sustain these vital regional assets.

2. Restore Funding for the Transportation Regional Incentive Program (TRIP)

Since created by legislation in 2006, the Transportation Regional Incentive Program has effectively catalyzed regional transportation planning and the development of regional transportation projects. However, the TRIP has only been effective when fully funded. The 50 percent of state matching grant funding has attracted considerable investment by local governments and by the private sector for regional transportation projects.

3. Continue Direction of State Transportation Dollars to the Central Florida Coast-to-Coast Connector Trail

The Central Florida Coast-to-Coast Trail from Titusville to St. Petersburg is 75 percent constructed with multiple gap segments advancing to the next phase of development. The legislature and governor this past session directed a minimum of \$15.5 million in FY 2014/15 to the development of the C2C Trail. By providing another infusion of state funds into the trail development, the C2C Trail can be expedited.

4. Index Local Option Fuel Taxes

The State of Florida long ago passed legislation to index state fuel taxes according to the Consumer Price Index. State gas taxes increase in Florida each year at a reasonable rate due to this indexing. Legislation is needed to provide the same annual indexing for local option fuel taxes. Fuel tax revenues for local projects have been affected by decreases in fuel consumption and a flattening of the revenue stream. Indexing would allow a more dependable revenue source for local transportation projects.

5. Enhance and Protect the State Transportation Trust Fund

In recent years, the Florida Legislature diverted massive funding levels from the State Transportation Trust Fund to balance the General Fund. \$6 billion in FDOT projects were deleted, totaling more than an entire fiscal year worth of projects. Such diversions of funds will result in the degradation of the state's transportation system and will dilute Florida's ability to be globally economically competitive.

6. Enhance and Protect the Transportation Disadvantaged Trust Fund

The Transportation Disadvantaged Trust Fund provides Florida's most vulnerable population access to medical services, nutrition, jobs and educational opportunities. With state-mandated changes in the coordinated system forthcoming regarding Medicaid trips, Florida counties have challenges ahead that will be exacerbated by funding diversions.

REGIONAL PROJECTS

1. Lake County CR 466A, Phase 3, Widening in Fruitland Park

The east-west regionally-significant county road connects The Villages east through Fruitland Park to US 27/441. Widening to four lanes has advanced such that two phases are now funded for construction. State funding is sought for the final phase, which is less than two miles in length.

2. Round Lake Road (Lake County)

With the Wekiva Parkway project moving closer to reality, the new SR 46 from the new SR 429 will be complete in 2019. Round Lake Road provides north-south access to SR 46 and the future Wekiva Parkway. Round Lake Road could provide more effective access if the roadway were to be extended two miles north to SR 44, thus opening regional access for much of eastern Lake County. State support is sought for this future regionally-significant corridor.

3. Citrus Grove Road (Lake County)

With the Minneola Interchange project moving forward, Florida's Turnpike in 2017 will see the opening of a new connection in South Lake. Citrus Grove Road is a planned four-lane east-west connection between the new interchange and US 27. Design of the roadway is moving forward. Funding for right-of-way and construction is needed.

4. Wekiva Trail (Mount Dora and Lake County)

With study underway and design funding programmed in the FDOT Five-Year Work Program, funding for right-of-way and construction is needed in order to connect downtown Mount Dora to the Coast to Coast Connector Trail in both Seminole and Orange counties.

STATEWIDE POLICY

1. Amend Statute: Charter County and Regional Transportation System Surtax

The current legislation allows an up-to-one-percent surtax, or sales tax, to be taken before voters as a referendum to fund transportation projects. The law has evolved through the last 25 years for the voter-enabled surtax to now be eligible to all 24 charter counties, as well as to any non-charter county that is part of a Regional Transportation Authority, resulting in 33 eligible urban counties. The transportation surtax is an appropriate referendum option for all Florida urban counties and, as a matter of statewide equity, should be extended to all urban counties served by a metropolitan planning organization. This would raise the number of eligible counties to approximately 40, including Lake and Sumter counties. The position has been supported by the Florida Association of Counties. During the 2013 session, the Florida League of Cities supported a bill that would expand eligibility to municipalities with a population of at least 150,000.

2. Monitor Legislation on Developments of Regional Impact (DRIs)

Legislation was proposed last session that would further dilute the laws guiding DRIs. Proponents of removing or reducing the DRI statutes claim that the local comprehensive planning process is adequate to address large developments. Meanwhile, planning proponents contest that DRI laws result in a much better planned regional development.

3. Weight Limits Maintained for Commercial Trucks on State Facilities

In 2010, the Florida Legislature raised truck weight limits on state roads from 80,000 to 88,000 pounds. Nationwide, "pilot projects" continue to push the envelope in terms of allowable weights on state and federal roads, with some states allowing 97,000 to potentially as much as 110,000 pound truck weights – this is without the provision of additional funding to mitigate the impacts of heavier vehicles on roads and especially bridges. MPO supports maintaining the current weight limits and encourages an assessment of fiscal impact of the recent increase in allowable truck weights.

4. Support a Statewide Comprehensive Rail System

Florida is in need of a comprehensive rail plan that maximizes economic development potential of freight rail while planning for the provision of expanded passenger rail services in urban metropolitan areas and between metro areas.

5. Transportation Related Legislation

With the removal of state-mandated transportation concurrency, the MPO supports legislation that strengthens home-rule rights of local governments regarding regional transportation partnerships and empowers local governments with funding and financing options.

6. Bicyclist and Pedestrian Safety

Building on the announcement of the "Complete Streets Policy" adoption by FDOT, the Florida Legislature should create legislation to address the Sunshine State's #1 ranking in the "Dangerous by Design" report. Florida has been #1 in bicycle and pedestrian fatalities for too long. The legislature should set statewide goals and a deadline to reduce Florida's bicycle and pedestrian fatalities.

PROJECT UPDATES

• US 301 Project Development and Environment Study (Sumter County) – US 301/SR 44 Intersection Improvements and US 301/Florida's Turnpike Interchange Improvements
US 301 is being studied from SR 44 in Wildwood south to C-470 (west) in Sumterville. The study is in the early stages. The study will lead to specific operational improvements and design improvements to the interchange of US 301 and Florida's Turnpike and to the intersection of US 301 and SR 44.

• I-75/CR 514 Interchange Planning (Sumter County near Coleman)

Staff is coordinating with Sumter County, FDOT and the Federal Highway Administration on an Interchange Justification Report and on an upcoming study of a potential new interchange with I-75 west of Coleman at CR 514. This effort will be coordinated with the US 301 study.

C-468/Florida's Turnpike Interchange (Sumter County)

The Sumter County Board of County Commissioners took action in 2014 on an agreement that will result in the construction of a full interchange at C-468 and Florida's Turnpike no later than 2025. The action shifts financial obligations back to the interchange after the obligations were in 2014 shifted from the interchange to US 301. The interchange is currently in the MPO's Transportation Plan.

C-470 Study

FDOT is moving forward with a Project Development and Environment Study for C-470 in Sumter County. The study will look at future needs for the roadway through 2040. The study is also part of an initiative to have 470 in both counties designated as a state road from I-75 in Sumter County east to US 27 in Lake County.

Wekiva Parkway Project

FDOT and the Central Florida Expressway Authority are now moving into the right-of-way acquisition phase for most segments of the project. Construction will be substantially underway by 2017.

Trails: Central Florida C2C Trail and Wekiva Trail

Because of the new Central Florida MPO Alliance prioritization of Regional Trails, all phases of the C2C Trail recently received advancements of funding from FDOT for each needed phase in both counties. The FDOT recently announced programming of the subsequent phases of each segment of the C2C. Meanwhile, the Wekiva Trail has two segments of four committed for construction to be complete by 2019. The other two segments are funded for the design phase.

• Minneola Interchange: Florida's Turnpike/North Hancock Road/Citrus Grove Road

Florida's Turnpike Enterprise has advertised for bids on a project to design and build the interchange. The FDOT TRIP grant for North Hancock Road will allow Lake County to meet FTE's timeline for construction to be complete by the end of 2016. Lake County's commitment will extend North Hancock Road from CR Old 50 to north of Fosgate Road. From that point north, the roadway would be included as part of the FTE design-build project. The final portion of the roadway, the extension of the roadway north from the interchange to CR 561A, will be constructed by the Hills of Minneola landowner. Meanwhile, an east-west connection to US 27 will be accomplished by building Citrus Grove Road as a four-lane roadway, which is soon under design.

• Lake-Orange Parkway (US 27 to SR 429)

The Orange-Lake Parkway Partners, LLC, is preparing an environmental report and the LLC is working with Florida's Turnpike on a traffic and revenue study to determine the viability of a potential toll road between US 27 in Clermont east to SR 429 just south of Winter Garden.

SR 50 Corridor Study

SR 50 is being studied from US 98 in Hernando County east to CR 33 in Mascotte. The study will look at safety and capacity needs and will take into account the environmental issues relative to the Green Swamp and the Withlacoochee State Forest.
