This ad is to serve as legal notice to open the official public review period for the FY 2015/16 – 2019/20 Transportation Improvement Program and the FY 2019/20-2034/35 List of Priority Projects on May 7, 2015. The Lake-Sumter Metropolitan Planning Organization (MPO) Governing Board will meet on Wednesday, May 27, 2015 at 2 p.m. at the Lake-Sumter MPO Office, 1616 South 14<sup>th</sup> Street, Leesburg, Florida, at this meeting the Board will adopt the MPO's FY 2015/16 – 2019/20 Transportation Improvement Program and the FY 2019/20-2034/35 List of Priority Projects. The public review period will close upon the adoption of the FY 2015/16 – 2019/20 Transportation Improvement Program and the FY 2019/20-2034/35 List of Priority Projects on May 27, 2015. The public is encouraged to participate in the adoption process of the Transportation Improvement Program and the List of Priority Projects. The Transportation Improvement Program is a federally-required document that all Metropolitan Planning Organizations are required to develop annually and represents the transportation improvements that have been programmed for the next five year period. This Transportation Improvement Program includes the Federal Transit Administration's (FTA) Program of Projects for Section 5307 Funding used to provide Fixed Route Transit services for Lake County. The development of this Transportation Improvement Program satisfies the federal public participation requirements for the Program of Projects.
