About the MPO

The Lake~Sumter Metropolitan Planning Organization (LSMPO) was established on Feb. 25, 2004, after the 2000 U.S. Census determined the urbanized area of Leesburg, Eustis and Lady Lake had exceeded the population threshold of 50,000 which requires establishment of an MPO. The MPO includes all of Lake County and Sumter County (Exhibit 1). Representatives of Lake County and Sumter County governments, the 14 municipalities of Lake County, the five (5) municipalities of Sumter County, the Florida Department of Transportation (FDOT), Florida Central Railroad, Lake County Schools, Sumter District Schools, the U.S. Department of Transportation (USDOT) and many others are involved in the transportation planning processes facilitated by LSMPO.

LSMPO's purpose is to provide effective leadership in the initiation and development of transportation plans, programs and strategies. As the governmental body in this planning area most directly responsible for the guidance of the transportation planning process, LSMPO ensures that recommendations and priorities comply with federal, state and local goals and requirements. LSMPO's major responsibilities include development and implementation of the following:

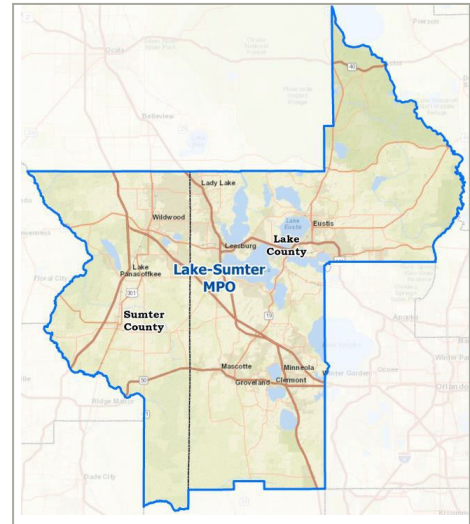


Exhibit 1: LSMPO Planning Area

- **Unified Planning Work Program (UPWP)**, prepared every two years to outline the budget and define the activities of LSMPO
- **Long Range Transportation Plan (LRTP)**, updated every five years to define the long-range cost feasible plan of projects
- **List of Priority Projects (LOPP)**, updated annually to identify LSMPO's top unfunded priority projects for inclusion in the Transportation Improvement Program and FDOT Five-Year Work Program
- **Transportation Improvement Program (TIP)**, updated annually to define the next five years of programmed projects
- **Public Participation Plan (PPP)**, reviewed annually to define LSMPO's public participation process, policies and approach
- **Transportation Disadvantaged Service Plan (TDSP)**, updated annually in coordination with the Community Transportation Coordinator and the Transportation Disadvantaged Coordinating Board
- **LSMPO Audit Report**, prepared annually to ensure that procedures and activities are being conducted in compliance with applicable requirements

Through the development of these and other products, LSMPO is responsible for ensuring adequate representation of and compatibility among state, county, and municipal projects in the transportation planning process. Public involvement is a major priority. Projects funded through public dollars are planned in a manner that encourages public participation and incorporates meaningful public input.

This includes ensuring that plans and priorities address the needs of underserved and underrepresented populations. For example, LSMPO incorporates into planning efforts the needs of the elderly and persons with disabilities as outlined in the Americans with Disabilities Act (ADA).

Introduction

This report summarizes the process for developing the 2025 List of Priority Projects (LOPP) and includes the complete list of priorities approved by the LSMPO Governing Board on June 18, 2025.

The annual LOPP is critical to the development of FDOT's Five-Year Work Program and LSMPO's Transportation Improvement Program (TIP). Each year, LSMPO prepares a TIP with highway, bicycle/pedestrian, and other transportation-related projects that are programmed for funding over the next five years. This process starts with development of the LOPP which consists of projects that have not yet been programmed but are considered the highest unfunded priorities.

Each MPO is required to develop a LOPP and submit it to FDOT by October 1st of each year, unless a different date is otherwise agreed upon (Section 339.175(8), Florida Statutes). For 2025, the deadline for submission was July 1st. LSMPO submitted the 2025 LOPP to FDOT District Five on July 1st. The 2025 LOPP will be used by FDOT to develop the FY 2026/27 - 2030/31 Tentative Five-Year Work Program which will guide LSMPO's development of the TIP for the same period.

The LOPP serves as a bridge between long range planning and project programming in the TIP and Work Program. Projects in the LOPP are the highest unfunded priorities within the MPO's planning area. After a Top Priority project has been fully funded in the TIP through construction, it is removed from the Top Priorities list, which allows other projects to be added or advanced in priority. These fully-funded projects will remain included in the LOPP within a "Funded Projects" list in order to emphasize their priority until completed. A project in the LOPP can be ranked higher and advanced more quickly if additional funds from local governments or other sources are utilized.

The mission of the Lake~Sumter Metropolitan Planning Organization is to provide the local governments, agencies and residents of Lake and Sumter counties a forum for addressing growth and transportation issues, with an emphasis on:

- (1) planning a regional, multi-modal transportation network that balances accessibility and mobility;
- (2) incorporating the visions of the member governments into a cohesive regional approach; and
- (3) coordinating with regional partners and state and federal agencies to meet the needs of the public.

Developing the 2025 List of Priority Projects

The projects within the LOPP should advance: the preservation of existing transportation infrastructure; enhancement of Florida's economic competitiveness; and improvement of travel choices to ensure mobility (Section 339.175(8), Florida Statutes). The following additional factors were considered in development of and prioritizing projects within the 2025 LOPP:

- Transportation needs and priorities identified by LSMPO, local governments and FDOT
- Goals and objectives of LSMPO's approved [Long Range Transportation Plan \(LRTP\)](#)
- The Strategic Intermodal System Plan developed under s. 339.64, F.S.
- Transportation Regional Incentive Program (TRIP) priorities (s. 339.2819(4), F.S.)
- Results of the transportation management systems ([LSMPO Congestion Management Process](#))
- LSMPO's public involvement procedures
- The goals, objectives, and policies of the local government's comprehensive plan
- Support for economic vitality, community development, business functionality, and creation or retention of employment opportunities

Exhibit 2 provides an overview of the steps and actions that were conducted to develop the 2025 LOPP.

In 2021, LSMPO developed new guidance to support development of the LOPP as part of the MPO's effort to continuously improve the prioritization process, enhance the quality of project information, and increase project funding success.

In 2022, LSMPO expanded its review process by beginning to integrate the results of its Congestion Management Process (CMP). The respective Congested Corridor designation (Extremely Congested, Congested, Approaching Congestion, or Not Congested/Operating at Acceptable Level of Service) for each project was included within the draft Top 20, Roadway Capacity (Non-SIS), and Planning Studies lists, where applicable. This CMP information was utilized to inform decision-making regarding priority rankings.

The 2025 LOPP prioritization process was continued from what was established in 2023 which added three additional informational factors to guide staff, committee, and Board decision-making on project priorities. Alongside CMP data, these additional factors included:

- Program Stability – Rank of project in previous LOPP
- Project Completion – Stage of Project Cycle (e.g. Design, Right-of-Way, or Construction)
- Safety – Crash Density (developed utilizing fatal and severe injury crash data obtained from FDOT's Crash Analysis Reporting (CAR) System and Signal Four Analytics)

It is anticipated that the prioritization process will continue to be refined in 2026 as the MPO adopts its 2050 LRTP in December 2025. See 2026 LOPP Process on page 4 for more information.

The 2025 LOPP is structured as follows:

- Table 1 – Top Priorities
- Table 2 – Strategic Intermodal System (SIS) Project Priorities
- Table 3 – Roadway Capacity (Non-SIS) Project Priorities
- Table 4 – Safety/Operations/TSM&O Project Priorities
- Table 5 – Complete Streets Project Priorities
- Table 6 – Trail Project Priorities
- Table 7 – Bicycle/Pedestrian & Sidewalk Project Priorities
- Table 8 – Transit Project Priorities
- Table 9 – Planning Study Priorities
- Table 10 – Bridge Project Priorities
- Table 11 – Small County Outreach Program (SCOP) Projects

The Top Priorities list is comprised of a range of projects from Tables 2-11, including roadway capacity, safety improvements, complete streets, and planning studies. The phases of work proposed for funding are:

- Twelve (12) Construction projects
- One (1) Right of Way project
- Five (5) Design projects
- Three (3) Planning projects

Immediately following the Top Priorities list is a Funded Projects list which includes projects from prior Top 20/Top Priority lists that have been funded through construction. Though they are removed from the Top 20, it is important to separately document them as funded projects until they are removed from the TIP to emphasize their importance.

2026 LOPP Process

Looking ahead to 2026, LSMPO will continue to strengthen the LOPP process as updated long-term needs and priorities are identified through the 2050 LRTP process. The 2026 LOPP will incorporate information and guidance from the 2050 LRTP and its associated elements (e.g. Complete Streets, Active Transportation, Freight, Safety/Vision Zero, Resilience, and TSM&O/ITS) to inform identification and prioritization of projects.

LOPP process refinements for 2026 may include:

- Incorporation of any ongoing guidance from FDOT on the development and submission of priority lists and applications
- Continued enhancement of the year-to-year predictability of lists and priorities;
- Continuation of the Funded Top Priority Projects List;
- Prioritization of key projects from sub-lists to shape the Top Priorities, including consideration of project category-specific criteria;

As done in previous LOPP cycles, the MPO may facilitate a partner agency workshop to discuss potential new criteria and obtain feedback for the development of a revised process that will be implemented for the 2026 LOPP.

Key Requirements and Activities

Performance Measurement

Performance measurement is an important part of performance-based planning and a key federal requirement. Performance measures and targets are considered in the development of LSMPO's Long Range Transportation Plan, Transportation Improvement Program (TIP), and the LOPP. Federally defined performance measures address Safety (PM 1), Bridge and Pavement Condition (PM 2), System Performance (Travel Time Reliability) (PM 3), Transit Asset Management (TAM), and Transit Safety. LSMPO supports FDOT's statewide targets for PM 1, PM 2, and PM 3, and supports LakeXpress and Sumter County Transit in achieving their respective transit-related performance targets.

Public Involvement

The public involvement approach for developing the 2025 LOPP was prepared pursuant to the LSMPO *Public Participation Plan*. Throughout the LOPP development process, there are opportunities for public comment. Prior to Board adoption, the public is provided with the opportunity to review and comment on the draft LOPP during a 21-day public review period. The public can also provide feedback during the public comment periods of each advisory committee meeting. During this review process and following Board adoption, the LOPP is electronically published on www.LakeSumterMPO.com and is available in print, by request. Citizens unable to attend the committee or Governing Board meetings may submit written public comments to LSMPO during the official public comment period: 1) via postal service, 2) on the MPO's website at <http://www.lakesumtermpo.com/engage/> or, 3) by emailing michael.woods@LakeSumterMPO.com. The process conducted to develop the 2025 LOPP is outlined in Exhibit 2. LOPP Amendments

Amendments to the plan are reviewed by LSMPO's advisory committees for input. The public is given the opportunity to comment on LOPP amendments through the public comment periods provided during each committee meeting and Board meeting, prior to Board action. During the review process and following Board adoption, the proposed amendment is electronically published.

Title VI Policy Statement & Responsibilities

The Lake~Sumter MPO assures that no person shall, based on race, color, national origin, sex, age, disability, family or religious status, as provided by Title VI of the Civil Rights Act of 1964, the Civil Rights Restoration Act of 1987 and the Florida Civil Rights Act of 1992, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination or retaliation under any program or activity. The Lake~Sumter MPO further assures that every effort will be made to ensure nondiscrimination in all its programs and activities, whether those programs and activities are federally funded or not. In the event the LSMPO distributes federal aid funds to another governmental entity, the MPO will include Title VI language in all written agreements and will monitor for compliance. The Executive Director is responsible for ensuring implementation of the organization's 2024 Title VI Nondiscrimination Plan and provides direction to the Title VI Specialist. The Title VI Specialist is responsible for the overall management and day-to-day administration of the Title VI program.

Limited English Proficiency (LEP) Policy

It is the policy of Lake~Sumter MPO to ensure that persons with limited English proficiency are neither discriminated against nor denied meaningful access to and participation in the organization's programs and services. It is the intent of the organization that in providing language services to persons with limited English proficiency, the process achieves a balance that ensures meaningful access to programs and services while not incurring undue burdens on resources of the organization.

The Lake~Sumter MPO will respond to requests for language assistance in the manner described in this plan, which includes:

- A mechanism to provide ongoing assessment of needs, programs, and activities of target audiences, along with the organization's capacity to meet these needs using the Limited English Proficiency Plan;
- Translation of vital written materials in languages other than English where there is a significant number or percentage of persons with limited English proficiency;

- Oral language assistance to LEP) persons for programs, where such assistance is requested and/or anticipated;
- Identified procedures and a designated representative from Lake~Sumter MPO responsible for implementing activities related to the Limited English Proficiency Plan;
- Notification of the availability of free language services to those persons in the target audience, through oral and written notice in the relevant primary language assistance activities; and
- Staff training on policies and procedures of the organization's language assistance activities.

All advertisements for public meetings sponsored by the Lake~Sumter MPO will contain the following language: "Persons who require special accommodations under the Americans with Disabilities Act or persons who require translation services, which are provided at no cost, should contact the Lake~Sumter MPO at (352) 315-0170 or by email to michael.woods@lakesumtermpo.com, at least three (3) business days prior to the event." RESOLUTION 2025-05

RESOLUTION OF THE LAKE~SUMTER METROPOLITAN PLANNING ORGANIZATION ADOPTING THE 2025 LIST OF PRIORITY PROJECTS AND AUTHORIZING TRANSMITTAL OF THE NEW FUNDING PRIORITIES TO THE FLORIDA DEPARTMENT OF TRANSPORTATION.

WHEREAS, the Lake~Sumter Metropolitan Planning Organization (MPO) is the duly designated and constituted body responsible for carrying out the urban transportation planning and programming process for Lake~Sumter Planning Area; and

WHEREAS, Section 339.175, Florida Statutes, 23 U.S.C. §134, and 49 U.S.C. §5303 require that the urbanized area, as a condition for the receipt of federal capital or operating assistance, has a continuing, cooperative, and comprehensive transportation planning process that results in plans and programs consistent with the comprehensively planned development of the urbanized area; and

WHEREAS, Section 339.175(8)(a), Florida Statutes, states that the MPO is responsible for developing, annually, a list of project priorities ranking the transportation needs of the MPO area; and

WHEREAS, the prevailing principles that must be considered by the MPO when developing the List of Priority Projects are preserving the existing transportation infrastructure, enhancing Florida's economic competitiveness, and improving travel choices to ensure mobility; and

WHEREAS, the 2025 List of Priority Projects is based upon project selection criteria that consider, in part, transportation needs and priorities identified by the MPO, local governments, and the Florida Department of Transportation (FDOT), the goals and objectives of the MPO long-range transportation plan; the FDOT Strategic Intermodal System Plan; criteria consistent with projects eligible to receive funding from the Transportation Regional Incentive Program outlined in Section 339.2819(4), Florida Statutes; the results of the transportation management systems; the MPO public involvement plan; goals, objectives, and policies of the local government's comprehensive plan, projects that lend support for economic vitality, community development, business functionality, and the creation or retention of employment opportunities; and

WHEREAS, the 2025 List of Priority Projects must be used by FDOT in developing the district work program and must be used by the MPO in developing its transportation improvement program; and

WHEREAS, FDOT has established a deadline of July 1, 2025, for the submittal of new project priorities, pursuant to Section 339.175(8)(b), Florida Statutes, with said priorities serving as a basis upon which FDOT District 5 makes funding decisions relative to the FDOT five-year Work Program; and

WHEREAS, the Lake~Sumter MPO, serving the role of prioritizing all federal-aid roadways, including certain county roadways, has prioritized county transportation projects to address regional county transportation needs within the MPO Area.

NOW, THEREFORE, BE IT RESOLVED by the Lake~Sumter MPO:

1. The 2025 List of Priority Projects was developed with consideration given to preserving the existing transportation infrastructure, enhancing Florida's economic competitiveness, and improving travel choices to ensure mobility; and
2. The 2025 List of Priority Projects is consistent with the MPO's adopted long-range transportation plan, *TRANSPORTATION 2045*, which was adopted on December 9, 2020; and
3. The 2025 List of Priority Projects is consistent with FDOT Strategic Intermodal System Plan; and
4. The 2025 List of Priority Projects was developed in consideration of criteria consistent with projects eligible to receive funding from the Transportation Regional Incentive Program outlined in Florida Statutes 339.2819(4); and
5. The 2025 List of Priority Projects was developed using the procedures of the MPO public involvement plan; and
6. The 2025 List of Priority Projects is hereby endorsed and adopted; and
7. The Chair of the MPO is authorized and directed to submit the 2025 List of Priority Projects to FDOT, the Chair of the Lake County Board of County Commissioners, and the Sumter County Board of County Commissioners.
